TO DISCUSS THE PLANNING APPLICATIONS FOR THE PARISH

PL 3344 91352/14

Land at former Horwich Loco Works

Part A – full planning application for site access, demolition of some and change of use of core heritage buildings for A1 and D2 leisure (both up to 2,500sqm) plus A2,A3,A4,A5,B1, C1 and D1 uses incl. car parking, diversions to public rights of way together with related associated works. Part B – outline application for residential development (C3) up to 1,700 dwellings, A1 retail (up to 2,500sqm) employment zone of B1 and B2 uses and up to 2,700sqm of ancillary D1 uses and up, children's play area, recreational open space and landscaping together with ecological mitigation areas, attenuation features and new cycle/pedestrian connections (means of access details only)

Following a public meeting arranged on Monday 17 March 2014 at Horwich RMI Club, Chorley New Road, Horwich it was noted that this meeting was very well attended and that headed sheets was available for any public in attendance tonight to put down their views.

Resolved to move out of Committee to allow members of the public present to speak.

A number of people expressed their concerns as in the previous meeting regarding education, health and green space needs. They felt that they have no trust in Bolton Council to have done a proper strategy plan for this and that they have no clear view on what is required.

Concerns were also raised as to asbestos and a member of the public had spoken to Health and Safety Executive who had no knowledge about this proposal. He wants Bolton Council to seek information from the H&S before proceeding.

A member of the public who said he spoke at length on Monday commented about the long term effects on Horwich, as this project, which would be the biggest building programme in Horwich for many years would be not for them but for their children and grandchildren and they have a duty of care to get it right.

Resolved to return to Committee.

Members of the Committee have taken on board all their comments however they are unable to envisage the number of school places need in the future and are unable to look so far ahead. They reported that Bolton are looking at the education needs through expansion of the primary schools but that secondary schools would need serous thought.

In reply to the comment about Health and Safety Executive, they would not have been informed because no planning decision has been made. They are of the opinion that their involvement may change because of the contamination and maybe an independent survey would be needed. But until outline permission is given no examination will go ahead.

Some members of the Committee are of the opinion that it would be best to get rid of a contaminated site and the inappropriate industry which is on site at present. Government have to identify development sites and it would be best on brown field site rather than green field sites. Members commented that if this planning application is not approved then contaminates will remain on site for the foreseeable future.

A Member asked the question why there are only two roads earmarked for through traffic and one for bus, it would be best that this bus route should also be earmarked for general traffic as it would be dependent on a bus company putting a bus in place.

Resolved to support the application in principle provided that the many issues raised at the Public Meeting of 17th March and in comments sent to the Planning Department, were satisfied. A 100% assurance on satisfactorily dealing with contamination was sought along with a traffic survey. Whilst the concept of the plan was thought to be good there are concerns over contamination, traffic, the provision of health, education and sports and recreation facilities (such as the provision for football in Horwich), Views had also been expressed on heritage and conservation.

Bolton Community College, Horwich Campus, Victoria Road Outline application for the erection of 140 dwellings (all matters reserved)

Resolved to move out of Committee to allow members of the public present to speak.

One member of the public highlighted her right to light and commented that she had already put in objections.

Representatives from St Mary's School were concerned about the lack of follow up from the developer to the community. At the moment their parents use the car park when attending the school. Also that due to the increased population the school would need to expand and a playing field will be needed. A copy of St Mary's School objection can be viewed at the Town Clerks office.

A member of the public gave the Council a copy of an O2 policy which can be viewed at the Town Clerks office. This topic of this policy is the "Protection of recreational open space"

A suggestion was made that the development could be changed to allow St Mary's to expand and to save the recreational site

Concerns were also raised regarding flooding (Nellies Clough) and a more detailed assessment needs to be done over this issue.

Resolved to return to Committee.

Councillors have taken on board what the Governors of St Marys have said and they have made some good points.

Bolton Council do not meet until 1 May 2014 and they propose to defer a decision to enable them to update Horwich Town Council on the traffic impact, light issues, flood risk and loss of amenities.

Resolved to defer this decision until the next meeting by 11 votes to 0 with 1 abstention.

Erection of two story extension at rear and single story porch extension at front.

The neighbour who lives at number 16 was very concerned about the intrusive aspect onto his property, it is a two story extension which would overshadow their principal room and he feels that is too big and too close to his property. It would also impact on his garden with loss of sunlight.

It is recommended that the planning office liaises with both property owners to bring about an amicable settlement

Resolved to refuse approval of this application by 11 votes to 0 with 1 abstention.
