In order to reserve her right to vote on Bolton Council's Planning Committee where the decisions about planning would be made Councillor Kellett would not take part in the discussion or voting

Unit 1, 567 Chorley New Road Erection of attenuation structure around existing plant equipment

Resolved to move out of Committee to allow a member of the public to speak.

Councillor Silvester, Ward Councillor for Horwich North East expressed his concern and objection to this application on grounds that if this structure is constructed then the loading bay will not be able to be used as HGVs/large lorries or any other vehicle will not be able to park fully within the loading bay. This will create problems to general vehicle movement within entrance to the site if lorries have to park on the general car parking area and cause an obstruction to other vehicles entering the site to park. It would also have an impact on the residents

of the apartments located above the retail units. Also emergency vehicles such as fire engines would be unable to access the full loading bay to extinguish a fire at the rear of the premises.

Resolved to return to Committee.

Members also expressed concern on this matter as if this planning application were to be approved then large HGV lorries would not be able to park within the loading bay which would contradict the previous design and access statement made, causing an negative impact on the present occupiers of the apartments above the retail units but also on vehicles entering the site to park up to shop. There was also concern that there is the potential for larger HGVs using the site if ownership of the store changes in the future.

Resolved to recommend refusal of this application on grounds that it will restrict servicing provision to existing businesses and create problems for general vehicle movement within the site.

Chorley New Road Primary School, Chorley New Road Variation of condition 04 on approval 97002/16 (to remove part of condition which refers to the existing clock tower (on the Victorian/original part of the school building) and its incorporation within the school grounds)

There had been 3 objections from Councillor Silvester, Horwich Heritage and 1 neighbouring resident on grounds that this well-known heritage feature should be retained.

Members were informed by the Town Clerk that Councillor McKeon had received information from the developer Wilmot Dixon on a proposal to remove the metal top of the clock tower and replace the wooden base with a new structure which would be sited on the new school site, subject to planning approval.

Resolved to recommend refusal of the current application as it is important that this feature is retained as it is an important part of Horwich' s heritage.

9 Shaftesbury Avenue, Lostock Erection of a single storey extension to side and rear.

There had been no objections. Resolved to recommend approval of this application.

04112/18 32 George Street Demolition of rear boundary wall to provide parking space, installation of roof lights and alterations to windows and doors.

There had been 1 objection from Horwich Heritage on grounds that the proposed works are unsympathetic to the property and the conservation area. Members expressed concern that a vehicle could protrude out of the parking space and obstruct pedestrian access. Resolved to recommend refusal of this application.

BWFC Eddie Davies Football Academy, Ox Hey Lane, Lostock Installation of underground foul pumping station.

There had been no objections. United Utilities had confirmed acceptance for the connection of the proposed rising main into a manhole on the new sewer system being constructed to serve the nearby residential development.

Resolved to recommend approval of this application.
