There had been 1 comment – vehicular access should be prevented at the top end of the development so a cut through is not created between Lever Park Avenue and Green Lane, officer commented that there is no cut through proposed, bollards are proposed at the end of the cul-de-sac, with the footpath only proposed in emergencies.

Members expressed concerns that the new house types would be bigger properties than those specified in the original application, however the planning officer had confirmed that they would be of a similar size and the bio diversity gain would also be similar.
