A summary of the Council's play and youth service funding for 2024 had been circulated to all Members. The Play and Youth Service offers positive activities for children and young people aged 4 – 17. The aim is to challenge, develop and support young people into adulthood, raising aspirations and contributing to the local community and this is done by delivering a number of age-appropriate sessions and events in youth clubs, community centres and public spaces using mobile vehicles. In addition, there is an Outreach Team that can respond to antisocial behaviour and signpost children and young people into local positive activities.

Horwich Town Council had agreed funding for 12 mobile play sessions and 2 skatepark sessions during the school holidays in 2024 as well as a bank of 12 outreach sessions as and when required, at a total cost of £5,940 from the youth provision budget.
