Councillor Denton informed the meeting that as Councillor Chadwick, as proposer of agenda items 10 and 11 had given his apologies and was not present, these proposals were subject to point 1 C of Standing Orders 'A motion on the agenda that is not moved by its proposer may be treated by the Chairman of the meeting as withdrawn.'

In response to a query it was pointed out that this was at the discretion of the Chair and Councillor Denton confirmed that she would allow discussion of these matters during Public Participation and that agenda items 10 and 11 would not be withdrawn.

Resolved to move out of committee to allow members of the public to speak.

Several members of the public present expressed their views on this matter with all expressing disappointment that Bolton Council's submission to host the Great British Railways Headquarters had not included Horwich as a potential location. It was agreed that Horwich Town Council should have been involved in the application process and kept fully updated, so as to provide a clearer understanding of the reasons why an alternative location had been put forward by the officers who had assessed the criteria and produced the application.

The Town Council had placed great emphasis on the town's railway heritage, however it was pointed out that deliverability of the project based on all of the stated criteria was extremely important. There was a suggestion that there was the possibility that GM may now threaten to take the bid away from Bolton. It was noted that a successful bid for Bolton would benefit Horwich as well by bringing skilled and highly paid jobs to the whole of the borough.

Resolved to move back into committee.

Members expressed their frustration and disappointment that Horwich had not been included in the bid in addition to Bolton town centre and also that Horwich Council had not been informed by Bolton Council about their decision and had only been told that Bolton Council had put in a bid for Bolton town centre two days after it had been submitted and that the reasons should have been explained in the Bolton Council meeting held the previous evening.

The view that Bolton would be unlikely to win the bid was expressed. It was felt that if Bolton Council had an issue with the proposed location within Horwich then they should have consulted with Horwich Town Council to find a resolution.

Councillor Brady confirmed that she had seen the draft bid on 14 March and had commented on it before it had been submitted. It was unclear who else had seen the draft as a request had to be made to view it. It was disappointing when an idea did not get taken forward but it was important to trust the judgement of experienced officerswho had written the bid.
