Mr Stevens, a local resident informed Members of investigations that he had undertaken to establish how ownership of Pickups Field had been transferred to Bolton Council and requested that the Town Council should take over this task.

Resolved to move back into Committee.

While there was full support expressed for residents' objections to the loss of, green space which would result from the proposed development, the cost implications of such action were queried and whether this was appropriate use of Council funds.

Resolved to move out of Committee to allow another member of the public to

speak.

Mr Halliwell, a local resident raised concerns about the state of some of the roads in Horwich, in particular Brownlow Road and Church Street and also inaccurate parking signage on Lee Lane.

Resolved to move back in to Committee.

Members agreed that there was clearly an issue with inconsistent and misleading signage and the poor condition of some roads in Horwich and a request was made to the Ward Councillors to take this matter up with Bolton Council and report back to Council.

Resolved to move out of Committee to allow another member of the public to speak.

Mr McGeehan, a local resident raised the matter of vehicles parking on the kerb on Curteis Street which prevented disabled access and also highlighted the lack of full disabled access to the Council Chamber.

Resolved to move back into Committee.

Members advised that the parking issue was an enforcement matter and shared concern at the lack of disabled access to the Council Chamber. It was noted that there was a stair lift but no level access as the back door not working at the moment. The Ward Councillors were asked to raise these matters with Bolton Council and report back to Council.

- the current account and the new mayoral charity account will be switched to internet banking while the salaries and wages and business reserve account will remain with the Council's current high street bank

Resolved to approve a change to the Council's current banking arrangements to internet banking and to amend the Council's Financial Regulations to

support this.

In response to a query it was confirmed that the Carnival Committee was on the list of outside bodies to which the Council appointed a representative.

Resolved to approve the request from Horwich Carnival Committee for grant funding of £2,500 towards 2019 Carnival events from the Sport, Social and Culture budget on the condition for more detail to be included in audited accounts for 2019 events, with the Town Clerk to be advised of relevant queries to be passed on to the Carnival Committee.

A draft letter had been prepared by the Steering Group to go to all businesses with the view to arrange a public meeting. In response to a query it was confirmed that businesses were aware of the Neighbourhood Plan, they appeared to have chosen not to engage with it, however it was hoped that this may change in anticipation of grant funding that Bolton Council is planning to make available for improvements to Horwich town centre
