45 objections had been received for this application which had been circulated to all Members prior to the meeting. Councillor Bullock informed members that he had attended the liaison committee which was rather subdued and felt the issues raised seemed to be concerns over the existing operations rather than the application itself. Members expressed concern over potential repeated applications and variations being made from the applicant. Members felt it wasn't possible to make an informed decision until further information had been provided. Councillor McKeon advised Members that the application would not be considered at Bolton Planning until end of May due to awaiting further information from the applicant.

It was noted that there was a feeling of disconnect with the Bolton Planning Officers who once attended Planning meetings as they gave Members and the public more information on important applications and answered queries and concerns residents may have had but due to financial cuts, this was no longer feasible.

Resolved to recommend a request from Councillor McKeon to receive a briefing from a Planning Officer prior to the meeting and to defer the application for consideration at the meeting of the Planning Committee on 18 April.
